By 2060, Africa's population is projected to reach 2.8 billion, from the current 1.26 billion; today, sixty percent of the population is below the age of 35, and Africa's middle class is growing. The region is strategically important to the United States because of its huge reserves of strategic and precious metals; crude oil; arable land; industrialization and innovative technology; and potential as a destination for U.S. investment, tourism and cultural exchanges. A non-stop flight from Dakar, Senegal to Miami, Florida, (the U.S. Gateway to the Western Hemisphere), takes approximately 6 hours and 30 minutes which is just about the time it takes a non-stop flight from Miami, Florida to San Francisco, California (6 hours 35 minutes), de-mystifying the current mindset that Africa is too far away from the United States.

This panel of experts will focus on innovative approaches to infrastructure development and transportation linkages required to make AGOA products and tourism more competitive between the U.S. and Sub Saharan Africa.
